President's Report

If you're not registered, please expect a letter from me asking you why you aren't registered and how we can get you registered. We need to make sure that all letter carriers are able to vote in the next election and that they come to the polls with a clear understanding of the candidates and their views. We need to make sure that we support candidates not only for ourselves, but for all of labor in Colorado. This election is going to determine many things for the next 10 years. With the 2020 census, there will be a redistricting of the state to accommodate 8 seats at the House of Representatives. Colorado is growing and we need to have equal representation with the entire country. At this time, the redistricting is decided by the party in charge of the Colorado House and Senate. We need to make sure that pro-labor is in charge. There's no better ending but to make sure that all Colorado's citizens are represented

But we need to remember we cannot use social media for partisan politics. Whether it's a like or share or whatever we're doing on social media on the clock, that is a violation of the Hatch Act. We are being scrutinized more and more every day, so we must be careful in all we do. To make sure that carriers are not violating the Hatch Act, we will not have any candidates at our State Convention. That is the reality we live in these days. That is a result of the 2016 election. We need to step up and pay attention. As one man said, if we see something, do something. I would like to change it to: if we see something VOTE.

Speaking of the state convention, our Sisters and Brothers from Arvada are working extremely hard to ensure that your 2018 convention is one to be remembered. Starting with golf on Thursday the 17th and concluding with adjournment on Saturday the 19th, we will have work filled days and fun filled times. Vice President's Report

Safety is up to you



A typical scenario is management having their daily safety huddles, and weekly safety messages telling us to be safe. Then they come around for leave and return times and ask you why it's going to take you so long. This, right after telling us to be safe! At times, this can seem like very conflicting information and that management pushes speed over safety. This can also cause carriers to feel like they

have to make a choice between making the numbers and safety. Some carriers are harassed and belittled daily on why they aren't meeting the numbers. (Those fictitious numbers in the sky) This is where safety is up to you. You can choose to either go faster than you should and ignore safety to meet those fictitious numbers. Or, the correct option would be to tell management you are going to be safe and get all of the mail delivered safely. Some subside to the pressure of management. It can be tough when you first start at the post office. I always tell our new carriers that the post office is a different animal. They want you to meet their fictitious numbers and not have any accidents. The minute you have an accident you can bet discipline is going to be right around the corner.

It is entirely up to the carrier to be safe. Those carriers who succumb to the pressure, and by doing so have an accident, are often rewarded with heavy discipline. Quite frequently issued are Notices of Removal or other severe discipline. The employee doesn't realize until it's too late that this is your call to make on a daily basis. There are tools to help you deal with the management pressure. Get your steward if you feel like you are being harassed at all by management. Making the numbers is no excuse for management to treat anyone poorly. difference is, that management is and should be asking for times and managing the workload, but they should do so by treating every employee with dignity and respect. If this isn't happening, please write a statement describing the conversation, what was said, and the behavior the supervisor exhibited. This will help your steward to have a conversation with the supervisor and file a grievance if possible. If you feel like management is making you choose between making the numbers and safety, ask them which safety rule they would like you to skip that day?

If you are a steward please help pass this information along to your fellow carriers. The National Agreement and Handbooks and Manuals are there to back up the enforcement of ALL safety provisions. Article 14 specifically states that management wants us to hold them accountable to enforce safety. Use this information to benefit every single employee to protect themselves.

You are the only one responsible for your safety when you are out there on the street. Every day, ask yourself, do I wear my seatbelt? Do I shut the door while driving? Do I turn the vehicle off before exiting, and pull the hand break? Do I curb my wheels to prevent a roll away? All of these steps are required and

you make the choice to be safe when you do these things. It only takes once to skip a safety measure and have something bad happen. Most who have had an accident or who have been caught failing to do a safety measure are issued harsh discipline. Most of these employees, if given the chance, would have taken the extra few seconds to do the job right. It's about creating good habits and doing everything the right way. It's amazing how easy these things are when you do them on a daily basis.

You have the choice to curtail mail if there is a dog loose, or if there is ice on the steps to get to a delivery. Just make sure you ask management for a PS Form 1571/curtailed mail slip upon return to the office for the mail you curtailed in an effort to stay safe. No one else can make this choice for you. We should all do this in our daily lives both at home and at work.

If you haven't already downloaded the NALC App, please do. Most importantly click on the information in the app about who your congressmen and women are and make the call anytime there are detrimental bills proposed that would hurt letter carrier jobs and benefits. Share it with your fellow carriers to make the call and express why it would be bad for you, your family and your fellow carriers.

DOES IT REALLY HELP TO CALL YOUR CONGRESSPERSON?

I want to tell you about my experience. I retired September 30, 2017. OPM (Office of Personnel Management) said it takes 3-6 months for them to determine the full amount a retiree is el-



igible to receive. During this time, OPM places you in interim payment status while they complete processing your application for benefits. You receive a portion of your retirement from OPM; mine was \$404.00/ month. I called OPM at the end of December 2017 to find the status of my application. I was informed it would be another 6-9 months from now. I

was thinking "WHAT!!" That would mean I wouldn't get my full retirement until a full year after my retirement. How was I going to live on \$404.00/month till then? I was WORRIED.

OPM told me that since I was divorced my application had to go to a paralegal to look at. As of now, they only have a few because of budget cuts. That's why it would take an extra 6-9 months. I was told Congress does the hiring for OPM employees. I called my National Business Agents Office, and asked what could be done to speed up the process. They informed me the union has no control over the OPM so they could not help me. They did instruct me to call NALC Director of Retirees, Ron Watson, to see what he would suggest.

I called Ron and told him my situation. He suggested that I call my congressperson and maybe they could help. I have a unique situation. I lived and worked in Colorado for the past 30 years and once I retired, I moved to North Dakota to help my aging parents. So which congressperson do I call CO or ND? Since I'm living in ND now, I decided to contact ND. I contacted

Senator John Hoeven's (R) office and they listened to my situation but had no answers. I was disappointed. Then I called Senator Heidi Heitkamp's (D) office. I informed Maggie, the senator's assistant, of my situation and was told to bring all my paperwork to their office in Minot, ND. I met with Maggie the next day. She took my information and told me they would look at it to see if they could expedite my retirement. This was the first part of January 2018.

The first week of February 2018 I received a letter from OPM paralegal saying they needed more information. I faxed the information to her the next day. I talked to her two days later and she was sending it back to the person that was assigned to my application. A week later I received a call from an OPM employee assigned to me and she informed me that my congressperson had called to have it expedited and it was done. Thanks to Senator Heidi Heitkamp my application was expedited. It took 1 1/2 months instead of the 6-9 months from the time I called my congressperson to get my full amount of retirement. DOES IT REALLY HELP TO CALL YOUR CONGRESSPERSON? YES, YES, YES it does. Please call your congressperson!

NALC members need to make their voices heard about the future of the Postal Service.

- 1. HRES 31 NALC Stance: NALC supports H. Res. 31, which call on USPS to restore the service standards that were in effect on July 1, 2012. Call and ask your congressperson to support HRES 31 for your future as a mail carrier and our customers.
- 2. HRES15. NALC Stance: NALC supports H. Res. 15, which calls on Congress and the Postal Service to take all appropriate steps to continue six-day mail delivery. Call and ask your congressperson to support HRES 15 to keep your jobs as a mail carrier and for the service we give our customers.
- 3. HRES 28. NALC Stance: NALC supports H.Res.28; Congress should take all appropriate measures to ensure continuation of door delivery for all customers. Call and ask your congressperson to support HRES 28 for our customers.

Combined Federal Campaign



I am looking forward to the 26th annual Letter Carriers Stamp Out Hunger Food Drive on May 12th. Branch 204 is sponsoring the Wildflower Elementary school to be part of our food drive. This will be our third year partnering with the school. The principal Wendy Godwin really loves having us there, she does an excellent job

exciting and teaching the students about helping our community.

For the last two years, the small elementary has filled a pro-master van with donations. We've been able to get pizza donated and the branch buys ice creams for the entire school. The Postal Service's PR department has issued a press release to all the local TV stations. The coverage gets the food drive on the local news the day before the drive instead of the day of. We've had increased donations since we started this. I would encourage other Branches to look into something similar.

We've been seeing a lot of carriers working off the clock. I understand people want to come in and go home as soon as they can; I spend way more time at the Post Office than I want to. Working off the clock and working through breaks works against us. Routes look smaller than they really are and when a different carrier must deliver it, it takes quite a bit longer. That carrier then catches all the grief from management on why it takes so long. It's management's job to make sure all the routes are adjusted to eight hours, but I've never seen them care unless the route is short. They want to dissolve routes, carrier and clerk positions, basically do more work with less people. We should all be working together making sure that we are preserving carrier positions, routes adjusted as close to eight hours as possible.

To qualify for a special route inspection, thirty minutes or more of overtime or auxiliary assistance, three days of the work week, six consecutive weeks. If there were 7 routes with an average of an hour over, those seven hours being cut off would realistically become another route, which means more regular positions.

Every day I see my brothers and sisters of the National Association of Letter Carriers look out for each other, from long retired friends to the city carrier assistants that walk onto the



The Letter Carrier Political Fund is invaluable in protecting you and your rights and is extremely easy to sign up for. Active letter carriers can contribute automatically using PostalEase to set up an allotment deduction from their paychecks which can be done either online or by phone. You can authorize a monthly contribution directly from your checking account as well. Retirees can give monthly by authorizing an automatic deduction from their annuity.

One of your best resources for up to date information is the National Association of Letter Carriers official website and the NALC App for your phone. The NALC phone app is free and user friendly providing convenient access to information that affects you and your working conditions daily. This is also a great resource for member health benefits, handbooks and manuals and pay increase information. Stay strong and I hope to see you at the upcoming State and National Conventions.

The new training process for the new CCAs was changed in late 2016 and has been undergoing constant upgrades since then. There is one thing we are lacking on throughout the district. We are needing committed on-the-job instructors in the field that will be willing to help guide the new CCAs when they come

out of the academy and are assigned to their offices.

The NBA's office works closely with branch presidents through the state trying to find candidates that will step up and lead the new CCAs as they continue towards their future career. This is strictly a volunteer position, but we would like to have carriers that have the heart of a teacher and are patient with those new trainees when they come on board. Do you know of someone in your office that would fit that role model? If so, please speak with them and see if they are interested. Anyone interested can contact their branch president and request to be an OJI. There is a required training class each OJI must attend.

There have been times in the past where a station doesn't have any certified OJI's and the new hires have been sent to another installation for training. This isn't the ideal situation, but it is required in the new training program. All CCAs must be trained by a certified OJI during the training at the office. This is critical so that each CCA is properly trained with the guidelines agreed to by the NALC and USPS. We need to work together to make sure management gives the new CCAs the proper training and hold management accountable when we see it isn't being done. We always make sure we go from start to finish with the grievance process. The training of a new employee shouldn't be any different. The learning never ends!

LCCL Reports

CD1 Diana Degette

On January, 15 2018, Jon Perkins (Br.5996) and I met with Rep. Diana DeGette's, staffer Arden Parker on to discuss the purposed 2019 budget asking Rep DeGette

to ask Congress to reject the White House's FY2019 budget proposals and how harmful the purposed budget would be to letter carriers and all federal employees. Arden said she would relay the information to Rep. DeGette. Key points discussed:

- Raising federal employees' pension contributions by up to 6.45 percent of pay over the next six years, costing active letter carriers up to \$3,600 per year.
- Eliminating cost-of-living adjustments (COLAs) for current and future retirees under the Federal Employees Retirement System (FERS).
- Reducing COLAs for the Civil Service Retirement System (CSRS) annuitants by 0.5 percent each year.
- Reducing CSRS and FERS pension benefits for new retirees by basing annuities on employees' highest average pay over five years (high-5) instead of over three years (high-3).
- Eliminating the annuity supplement that covers the gap for employees who retire under FERS before they qualify for Social Security benefits at age 62.
- Slashing the rate of interest paid on assets invested in the Thrift Savings Plan Government Securities Fund (G Fund), costing active and retired letter carriers alike \$32 billion over 10 years.
- \$45 billion in revenue changes and vaguely defined cuts to the Postal Service, most likely through reducing the frequency of delivery (eliminating Saturday delivery) and scaling back door delivery.
- Making the financially independent U.S. Postal Service part of the federal budget moving it from an "off-budget" status to an "on-budget" status and potentially opening the agency to across-the-board spending cuts and service disruptions should the federal government shut down during budget conflicts.
- Authority for higher postage rates. Rather than resolving the pre-funding burden, the budget seems to propose giving the Postal Service greater freedom to raise rates to cover future retiree health care costs. As a result, the administration's postal proposals are certain to be opposed by all of the Postal Service's major stakeholders, unions and mailers alike.

Sadly, the administration seems to have learned little in its first year in office the 2019 purposed budget is almost identical to the 2018 purposed budget. Letter carriers must not let their guard down these budget threats are very real. All letter carriers as well as family members, friends and neighbors need to contact representatives in the House and Senate now! Your legislators need to know that their voters object to slashing the incomes of active and retired letter carriers (and all federal employees) and to gutting the services and vital networks of the U.S. Postal Service.

The big news out of CD2 is that our current Representative, Jared Polis, has made the decision to run for Governor of Colorado. In order to do that he will be giving up his seat in Congress. That means that this November the voters of the Second Congressional District will be choosing his successor and that starting next year we will have a new Representative in Washington, D.C. We are not far enough along in the process, as I write this, that our union has made any formal decision about who we will endorse.

The Colorado AFL-CIO's COPE (Committee on Political Education) convention will be held at the end of April, at which time they will take a look at candidates who are running for office this fall and begin the process of deciding which of the candidates organized labor will endorse. Without getting too much into the weeds, there are signs that there are at least some of the candidates who are running who have a good grasp of the issues important to our union and the challenges facing the Postal Service going forward be counted on to back things like legislation to continue delivering mail six days a week and bringing our customer's mail to their door, instead of them having to walk around the neighborhood to retrieve their mail from a cluster box.

We are frequently told that the election coming up is especially important, so we need to be paying attention. In part, that is because it is always true. The six day bill and the bill to eliminate door to door delivery, for example, would eliminate literally tens of thousands of letter carrier jobs while providing worse service to our customers. That makes it important to elect people who will prevent that from happening.

I recently had a meeting with Congressman Mike Coffman to discuss the possibility of him signing House Resolution 31, 28, and 15. House Resolution 31 is about having the USPS service standards to be restored the way it was before July 1, 2012. House Resolution 28 is about protecting door delivery. House Resolution 15 is about keeping six day delivery. These are House Resolutions that we, as letter carriers, keep advocating for and we will continue to do so.

Another goal I had was to discuss the new threat that is upon us which is the White House's FY 2019 Budget proposal. One of the many threats for example is the increase on FERS contributions. This will cut our pay and raise our pension contributions by 1 percent each year for up to 6 years costing us up to \$3,600 annually after 6 years. It does not get any better; this proposal will slash Cost of Living Adjustments (COLA) for all retirees. Retirees who depend on annual COLAs will not keep up with cost of living. Please refer to the NALC website or app for more information on the White House FY 2019 Budget Proposal.

I was joined by my fellow letter carriers Jeff Sipple, Charlie Trujillo, and Barb Larson. Barb Larson and I asked Jeff Sipple and Charlies Trujillo to join us in the meeting because they are both veterans. Congressman Mike Coffman is a big supporter of veterans. The meeting went very well and congressman Mike Coffman does not think the White House FY 2019 Budget Proposal will pass (We hope so too!). We also discussed how important House Resolutions 31, 28, and 15 are to the Postal Sevice. Congressman Coffman said that he will have his Chief of Staff Ben Stein have a follow up meeting with us.

The primaries for the 2018 election for House of Representatives for Congressional District 6 are coming. I encourage everyone to participate as well as the election for Congressional District 6 for 2018 House of Representatives. I also urge all letter carriers to call your Congressman and ask them not to support the White House FY 2019 Budget proposal.

Many of the articles in this issue of the NALC'er mention the Hatch Act, discuss politics and encourage you to participate in political activities. The NALC Constitution and our State by-laws establish that the COSALC objective is "to guide and direct all activites relating to legislation within the state." You may think or believe the officers of the state are going too far in their discussions of politics, but that is their job. It is also their job to advise you of what you can and can't do

as an employee of the United States Postal Service. For that reason, I believe it is imperative we all review the following guidelines. Jo Schuetz - Editor, COSALC NALCer

Active letter carriers may—on their own time, away from work, out of uniform and without using a postal vehicle:

- •Be candidates for public office in non-partisan elections (that is, elections in which none of the candidates are to be nominated or elected are representing a political party).
- •Register and vote.
- •Sign and circulate candidate nominating petitions and ballot initiative positions.
- •Assist in voter-registration drives.
- •Speak and write publicly and otherwise express opinions about candidates, ballot measures and issues.
- •Attend political rallies, meetings and other events.
- Attend fundraisers and contribute money to political organizations and campaigns.
- $\bullet \mbox{Volunteer}$ for political campaigns and encourage others to volunteer.
- •Participate in phone-banking and precinct-walking for candidates and ballot measures.
- •Display bumper stickers, lawn signs and other campaign paraphernalia.
- •Raise money for the Letter Carrier Political Fund from other NALC members. (Note: Letter carriers while detailed to 204b or other higher level assignments should not solicit contributions to the Letter Carrier Political Fund from postal employees who may be viewed as their subordinates.)
- $\bullet \mbox{Volunteer},$ run for and hold an office in a local or state political party or club.

$Don \verb|'ts| (while on the clock, at the workplace, in uniform or in a postal vehicle)$

Active letter carriers may not—while on the clock, at the workplace, in a postal uniform or in a postal vehicle—engage in any of the otherwise permissible political activities listed in the "Do's" above. For example, while on the clock, at the workplace, in a postal uniform or in a postal vehicle, you may not:

- •Send or forward a partisan political e-mail.
- •Wear or display any political or campaign material, even as a computer screen-saver or desktop wallpaper.
- •Circulate partisan political materials to co-workers.
- •Sign up electronically to contribute to the Letter Carrier Political Fund or solicit other letter carriers to contribute.

Don'ts (ever)

Active letter carriers may not—even on their own time, away from work, out of uniform and without using a postal vehicle:

- •Use their official titles or positions when engaging in otherwise permissible activities.
- •Raise money for partisan political groups or campaigns (except for the Letter Carrier Political Fund), including phone-banking, letter-writing, selling tickets, hosting a fundraiser, inviting people to attend a fundraiser, or allowing your name to be used in a fundraising appeal.
- •Otherwise solicit, receive or handle contributions for a partisan political group or campaign.
- •Run for elective office in partisan (party-label) elections (even if you report "No Party Affiliation").
- $\bullet \text{Raise money for the Letter Carrier Political Fund from non-NALC members (except from their immediate family members in the same household)}. \\$

Letter Carrier Political Fund

By making a contribution to the Letter Carrier Political Fund, you are doing so voluntarily with the understanding that your contribution is not a condition of membership in the National Association of Letter Carriers or of employment by the Postal Service, nor is it part of union dues. You have a right to refuse to contribute without any reprisal. The Letter Carrier Political Fund will use the money it receives to contribute to candidates for federal office and undertake other political spending as permitted by law. Your selection shall remain in full force and effect until cancelled. Contributions to the Letter Carrier Political Fund are not deductible for federal income tax purposes. Federal law prohibits the Letter Carrier Political Fund from soliciting contributions from individuals who are not NALC members, executive and administrative staff or their families. Any contribution received from such an individual will be refunded to that contributor. Federal law requires us to use our best efforts to collect and report the name, mailing address, occupation and name of employer of individuals whose contributions exceed \$200 per calendar year. Any guideline amount is merely a suggestion, and an individual is free to contribute more or less than the guideline suggests and the Union will not favor or disadvantage anyone by reason of the amount of their contribution or their decision not to contribute.
